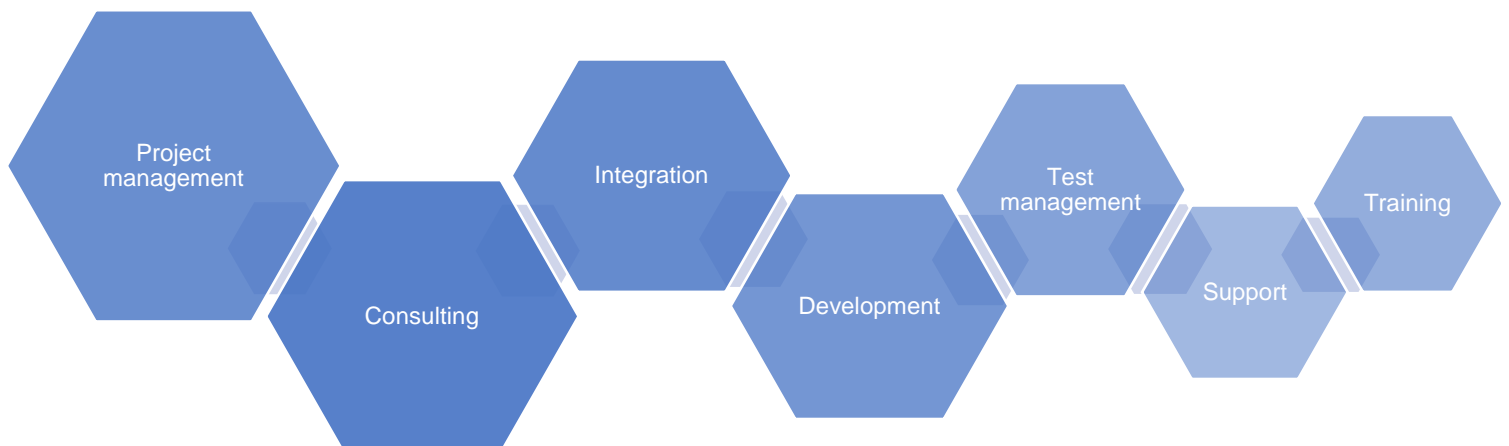

## 1. Initial version V2020/10

The UDI EUDAMED Add-On was developed for master data management and data transfer of UDI relevant attributes. It supports you in compiling and managing all data required by the European Commission and helps you to transfer them to the European Commission database (EUDAMED).

### 1.2 Code lists

Within these SAP transactions, default values are created for the dropdown lists in the UDI master data maintenance. For this purpose, unit value ranges recorded by the company and approval data are determined. In addition, these values are used as input checks and when uploading data for data verification.
