

# 1.2 Change Log

#### 1.2.1 SRN authorization function

A new authorization check based on the SRN was implemented. Users should have restricted rights to create/change BASIC UDI-DI records for specific SRN and plants. That means a new authorization object is needed to restrict the access on SRN level. The restriction on plant level can be realized using SAP standard authorization for plants. In a customizing table should be entered the combination between SRN and plants. An additional field is needed, which indicates if the SRN/ plant combination is active.

The affected SAP applications are:

- /UDI/MAINTAIN
  - Basic UDI-DI: Check user authorization if he used the right SRN number for which he is authorized while saving
  - UDI-DI: Check user authorization if he is assigning the right plant/SRN combination and if he has plant authorization for that specific material
- /UDI/ATTRIBUTES
  - o User should be able to show only SRN and plant for which he is authorized
- /UDI/UPLOAD
  - User should be able to upload only data (BASIC and UDI-DI) for which he is authorized
  - Combination of BASIC SRN and Material Plant should correspond to SRN/PLANT customizing table
- /UDI/EXPORT
  - o Export should be able only for which is the user authorized

#### 1.2.2 New selection criteria for Basic UDI-DI

For all UDI transactions the entry mask was improved with the following feature:

• A new selection criteria "Applicable Legislation" on Basic UDI-DI level was implemented

The UDI attributes function was improved with the following features:

 A new selection screen was implemented that allows to display only released and only changed data

# 1.2.5 Subtable "Certificate Links"

The Basic UDI-DI subtable "Certificate Links" was adjusted in line with the EUDAMED updates. The following columns were adjusted:

- Remove column "NB Reason"
- Remove column "NB Decision Reason"
- Remove column "Decision Date"
- Remove column "Decision Applicability Date"
- Remove column "Issue Date"
- Remove column "Status"

Accordingly, the EUDAMED upload template was adjusted for the correct import and export of the certificate link data in excel into SAP.

#### 1.2.6 Subtable "Substance"

The UDI-DI subtable "Substance" was adjusted in line with the EUDAMED updates. For the "Medical Human" and "CMR Endocrine" substances the following columns were adjusted:

- Add column "Group" with fieldname SUBSTANCE INDEX
- Add column "Custom language" with fieldname SPRAS
- Add column "Substance Name" with fieldname LONG\_TEXT

These additional columns allow to "Group" the substances together, in case that the substance is described in "Substance Name" in different "Languages", i.e. multiple entries for the same substance with translations in other languages are made and assembled in one group.

Further the editability of the subtable was determined according to the "INN" for medical & human substances and the "CAS/ EC" for CMR endocrine substances:

- If the "INN" or "CAS/EC" code is entered not further editable
- If the "INN" or "CAS/ EC" code is not entered language dependent value for substance name, one language can only be used once

#### 1.2.7 Subtable "Storage & Handling Conditions"

The UDI-DI subtable "Storage & Handling Conditions" was adjusted in line with the EUDAMED updates. The following columns were adjusted:

- Add column "Group" with fieldname CONDITION\_NUMBER
- Add column "Custom language" with fieldname SPRAS
- Add column "Description" with fieldname COMMENTS
- Add code lists for column "Storage & Handling conditions" with fieldname STHACO

Further the editability of the subtable was determined according to the "Storage & Handling type" selection:

- Codes without \* not editable
- Codes with \* language independent value for description
- Code with \*\* (OTHER\*\*) language dependent value for description, one language can only be used once

#### 1.2.8 Subtable "Critical Warnings"

The UDI-DI subtable "Critical Warnings" was adjusted in line with the EUDAMED updates. The editability of the subtable was determined according to the "Critical warning type" selection:

- Codes without \* not editable
- Codes with \* language independent value for description
- Code with \*\* (OTHER\*\*) language dependent value for description, one language can only be used once

#### 1.2.9 Subtable "Clinical Size"

The UDI-DI subtable "Clinical Size" was adjusted in line with the EUDAMED updates. Based on the "Precision" the clinical sizes are now editable. When the "Precision" is:

- "Range" "Size unit", "Value/ Min. value", "Max value" can be edited
- "Value" "Size unit", "Value/ Min. value" can be edited
- "Text" "Text" can be edited

#### 1.2.10 Subtable "EMDN"

The UDI-DI subtable "EMDN" was created in line with the EUDAMED updates. The following columns were adjusted:

- Add column "Nomenclature Code (EMDN)" with fieldname EMDN and the respective code list
- Add column "Description" with fieldname DESCR
- Remove the UDI attribute "EMDN Code" on the UDI-DI level

## 1.2.11 Triggerfields adjustment

The UDI trigger fields were adjusted in line with the EUDAMED updates. The following UDI fields were adjusted:

- New triggerfield "Trade name"

- · New triggerfield "Critical warning"
- New triggerfield "CRM Endocrine substance"
- New triggerfield "Direct Marking"

#### 1.2.12 Release of UDI-DI

Bugfix of release checkbox on Basic UDI-DI and UDI-DI level. Display of the checkbox is always provided as well as the possibility to check and uncheck the release. If all UDI-DI's are released the flag "ALL\_DI\_RELEASED" shown on Basic UDI-DI level is set automatically.

#### 1.2.14 Number of hits

Bugfix of the number of hits, displaying the real number of records as hits and not the entered value. Therefore, if the entered value exceeds the number of records, the maximum number of records will be displayed in hits.

- New field "Issue Date"

- Display fields in ALV Basic UDI-DI
- Resize of ALV
